Community Engagement programs provide a speaker's bureau, partnerships to promote healthy child development and strengthen policy and regulations impacting young children. Early childhood education is promoted a high - priority public policy issue in our region with adequate support necessary to deliver quality program for parents, children, and teachers.

Materials and equipment programs provides the use of learning resource materials and equipment to area early childhood educators and childcare providers. CFC works with eligible child care centers to assess their resource material/equipment needs. Under its contractual agreement with the Houston - Galveston Area Council (Workforce Solutions), CFC administered the placement of approximately \$1.2 million of resource materials and equipment to over 250 childcare centers within the region. Funding of this program originated from the U.S. Department of Health and Human Services block grants and during 2011, included a significant amount of federal stimulus funds.
